



Jury Information & Dates:

1. **ELECTRONIC/ ENTRY FEE:** All entries will be done electronically via website Entry Portal. **Entry fee, \$35 for up to 2 entries.**
2. **ENTRY FEE PROCESSING:** Using entrant Credit Card OR PayPal account, payment will be processed through Paypal.com to **Experience FiberArt, Inc.** Entry fee is non-refundable.
3. **SALES:** If the artist chooses to have their piece for sale, the artist will receive 80% of the retail price, in US dollars, listed on this form. Liability for all taxes associated with income from the sale of artwork or from an award is the sole responsibility of the artist. In the instance of sale, the artist must provide appropriate personal information for 1099 tax reporting. **Sale of juried piece is optional.**
4. **AWARDS:** Awards will be announced and distributed at the Opening Reception on October 7, 2017.
5. **DEADLINE:** Payment, entry form and digital images must be sent no later than **June 1, 2017** Electronic Submission only. Please visit **www.experiencefiberart.com**
6. **ENTRY IMAGES:** Entries will be accepted in digital format only, via DropBox during the online entry process. Images must be of completed work. Each work will require a set of two (2) digital images. One image must show the overall work, including the edges. The second image must show a detailed area of the work.
7. **DIGITAL IMAGE SPECS:** **File type:** JPG. The "JPG" file must be formatted to be PC compatible. **Maximum file size 2MB**
Resolution: Minimum acceptable resolution is 300 dpi.
Labeling Full Image: *Artist's Last Name_Title of Work_height x width* (in inches)
Labeling Detail Image: *Artist's Last Name_Title of Work_detail*
All images will be uploaded during the online order entry process.
8. **ACCEPTANCE NOTIFICATION:** Notification of acceptance will be emailed to applicant by **July 15, 2017.**

Submission Content and Hanging Requirements:

1. **MATERIALS:** All artwork work must original. It must be predominately fiber. We accept woven, felted and quilted assemblage. Integration of non-fiber items welcomed. Artwork derived from kits, classes or commercial patterns are **not** eligible.

2-D artwork - Must include a sleeve and/or other hardware for hanging.
3-D artwork - Must include structural components to make the artwork free standing.

Framed artwork must meet gallery standards and should include the following elements:
Professional frame – Nielson or profession type frame
Archival Mat – white, black or gray
Hanging - Wire on back
2. **DIMENSIONS:** 2-D artwork:
Minimum Length 44". Minimum Width 22"
UP TO A Maximum Length 72". Maximum Width 60"

3-D artwork:
Maximum height 36", width and depth 14"
3. **LABELING:** All packaging and artwork **must** be labeled with artwork title, your name, address and phone no.

**2. PACKAGING/
SHIPPING:**
